Re: Course accreditation for the National Center for Healthy Housing, Inc. Initial Lead-Based Paint Renovator (English) Course

The Utah Division of Air Quality (DAQ) Lead-Based Paint (LBP) Program has reviewed course materials submitted by National Center for Healthy Housing, Inc. (NCHH) dated May 5, 2010. NCHH has provided the aforementioned materials to the DAQ for course review under Utah Administrative Code (UAC) R307-842-1, Accreditation of training programs: target housing and child-occupied facilities.

The DAQ has completed a desk audit of the LBP training provider course materials submitted by NCHH and hereby grants course accreditation for the NCHH Initial Renovator (English) course. This letter serves as the certificate for course accreditation, as required by UAC R307-842-1 and 40 CFR 745.225(b)(2), for the NCHH Initial Renovator (English) course. Course accreditation shall be retroactive to April 8, 2010, that will allow students who successfully completed the courses taught during the interim accreditation period (outlined in our correspondence DAQA-283-10 dated April 8, 2010), to have completed a DAQ accredited course for individual certification purposes. This course is accredited through April 8, 2014, or until further action by the Executive Secretary.

Your DAQ accredited training course is subject to the following restrictions:

1. Course accreditation pertains only to training individuals for purposes of obtaining certification to conduct regulated LBP work activities as defined in UAC R307-840.
2. The DAQ LBP program may revoke or suspend its accreditation of any training program or course if subsequent alterations or deviations in the program or course result in noncompliance with the standards found in UAC R307-840, UAC R307-841, and/or UAC R307-842.

3. Accredited LBP training programs must notify the DAQ LBP program in advance of any planned changes in the training course curriculum or instructional materials, and about any planned changes in key program personnel (including the training manager or principal instructor).
4. The DAQ LBP program must be notified in writing (by mail or fax) at least 7 business days prior to each offering or a change in location of an accredited LBP training course taught in Utah. The DAQ LBP program must also be notified at least 2 business days prior to any course cancellation.
5. The DAQ LBP program may conduct an on-site audit and/or inspection to ensure continued compliance with UAC R307-842.
