Retrospective

What Happened?

- The final Omnibus Appropriations Bill passed in December 2011 (Public Law 112-74) cut FY12 funding for the CDC's Healthy Homes and Lead Poisoning Prevention Program to \$2 million—a 94% reduction from FY11.
- The final HUD spending bill reduced the amount of funding for Healthy Homes from \$20 million to \$10 million.

Appropriations Language in 2012 in Senate Report

CDC: "Healthy Homes and Lead Poisoning Program. The Committee notes that \$350m will be spent by DHHS to conduct home visiting programs in fiscal 2012 through the Maternal, Infant, and Early Childhood Home Visiting Program; this funding appropriated by the Patient Protection and Affordable Care Act, is \$100m for than the fiscal year 2011 level. The Committee intends the Health Resources and Services Administration and CDC to work together to ensure that activities previously funded through Healthy Homes will be fully incorporated into the Home Visiting Program (p 78)."

HRSA: “Healthy Homes—The Committee supports efforts by HRSA to fund evidence-based maternal, infant and early childhood home visiting programs that are consistent with the Patient Protection and Affordable Care Act. The Committee is aware of **nurse home visiting programs in New York State, Rhode Island and Oklahoma that have adopted healthy homes activities as part of their programming.** This integrative approach of identifying and preventing environmental health and safety hazards in the homes of high-risk pregnant mothers and their babies is a cost-effective and efficient strategy for preventing disease and injury among the Nation’s most vulnerable families. **The Committee recommends that HRSA expand and incentivize the implementation of these integrative programs** in consultation with the Centers for Disease Control and Prevention.”

"The conferees intend that the funds provided for the CDC lead poisoning program be used to maintain expertise and analysis at the national level and to provide a resource for States and localities."


- Created Advocacy Guide

- Briefed state and local CLPPP directors, CDC's advisory committee, NCHH's board, and other national NGOs.





Looking Ahead

Goals

1. Backfill the 2012 funding for the CDC Lead and Healthy Homes Program through re-allocation of HHS funds
2. Restore CDC's Lead and Healthy Homes Program budget in 2013 (to FY11 level - \$29 million).
3. Support President's request for Office of Healthy Homes and Lead Hazard Control program.

Looking Ahead: President's Budget

- CDC is cut dramatically within HHS, by \$665M, which is 12% below FY12 and 22% or \$1.4B below FY10
- CDC proposes a consolidated “Healthy Homes and Community Environment” initiative to combine asthma and lead/healthy homes (same as FY12)
- The President’s budget requests funding for this new initiative at \$27M with no delineation of funds between the asthma and lead programs
- HUD’s funding for lead and healthy homes is flat at \$120M, but provides an increase to \$30M for healthy homes
